I. PREAMBLE

The academic teaching hospital St. Vinzenz Betriebs GmbH Zams in Austria and St. Francis University College of Health and Allied Sciences (SFUCHAS) in Tanzania in accordance with a mutual objective to produce the world class human resource for health who have high competence in the areas of research, teaching and patient care, hereby jointly enter into a multilateral linkage, focusing on the development of their institutions' programs. They will jointly develop and implement activities to improve their capacities to serve their respective clientele.

II. OBJECTIVES

The objective of this linkage is to develop long-term cooperative activities. The activities may include, but are not limited to, the following:

- i. Share knowledge and skills
- ii. Develop exchange and professional development programs for students, staff and faculty
- iii. Conduct seminars and workshops
- iv. Share new technologies and new methods of management through extension and other programs

III. PROGRAM MANAGEMENT

The St. Vinzenz Betriebs GmbH Zams in Austria and St. Francis University College of Health and Allied Sciences (SFUCHAS) in Tanzania jointly agree to develop and establish provisions for program implementation that will serve the mutual interest of the above-mentioned institutions.

It is understood that the details of joint activities, conditions for utilization of result achieved, and arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific type of activity.

It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supporting the exchange and collaboration. The contact and exchange between the parties shall be on the basis of friendship, equality, and mutual assistance a win-win approach. The programs at SFUCHAS are the responsibility of the College Management or the body identified by Management.

IV. TERMS OF AGREEMENT

This agreement is effective on the date of the last signature hereto and will remain in effect for an initial period of three years and may be extended for a period as mutually agreed by the parties. The institutions can terminate the agreement by giving two months written notice to the other party.

The activities under this agreement will be reviewed on an annual basis as mutually agreed and plans for future activities will be developed each year immediately following the review.
